

# Continuing Professional Development



- Continuing professional development (CPD) for social workers is regulated by Social Work England (SWE), which sets the standards needed for continued registration;
- All those within the Teaching Partnership will be supported to continue to develop their skills and improve their practice through learning and development opportunities, within their own agencies and beyond;
- Learning can and does take place in a variety of ways and in different circumstances so the Professional Capabilities Framework (PCF) and Knowledge & Skills Statement (KSS) act as a framework to inform CPD requirements for individual Social Workers;
- Staff will be supported by their managers to take professional responsibility for developing their skills to a high professional standard.



# About CPD Passport



- Continuing Professional Development (CPD) training opportunities are provided through your organisation's Learning & Development programme, which will be enhanced by the ability to access CPD training across the Partnership via our 'CPD Passport' scheme;
