# Introduction

Welcome to the Teaching Partnership (TP)'s first Annual Learning and Development (L&D) Report 2020-21. This covers over 75 events across all the different programmes offered by the TP between April 2020 and March 2021.

Due to the coronavirus pandemic and lockdown regulations coming into effect in March 2020, a number of events in April, May and June were either cancelled or postponed, and all subsequent events have been held virtually.

The L&D offer was developed in conjunction with partners, incorporating feedback from stakeholder surveys and event evaluations as well as considering the popularity of events, with the aim to support high standards of learning and practice across the partnership. *Appendix 1* shows a version of the CPD brochure for the time period, although iterations are released throughout the year as new events are added. This brochure includes events that are part of the CPD Passport with other partners (events that partners are happy to open up across the partnership) and events from Kingston University. This report will focus on the TP L&D offer.

The TP operates a two-tier membership structure, with primary and secondary partners<sup>1</sup>. The primary partners have access to the full TP provision and CPD Passport offer whereas secondary partners are able to access provision that relates to Practice Education and Anti-Racism only.

The L&D offer supported Practice Educators (PEs), ASYE Assessors, On-site Supervisors (OSS), Newly Qualified Social Workers (NQSWS) and Managers with specific programmes, as well as all pre- and post-qualified colleagues more generally. Having all of these programmes are a key part of the student placement arrangements with Kingston University and recruitment, retention and upskilling of the workforce. In addition, the TP was able to secure additional COVID funding partway through the year, which contributed to a number of courses and resources for NQSWS. Following the tragic murder of George Floyd in May 2020, a number of partner agencies announced practical actions they would be taking to address the role that they and the social work profession must play in addressing the injustice and racism that led to his death. To support this, the TP Team started facilitating discussion groups and invited key speakers to deliver events on anti-racism.

A number of resources have been made available through the Developing Together Teaching Partnership [website](#), including videos, blogs, recordings of some training sessions, documents and newsletters.

The overall approach of the TP for the delivery of training is to draw on internal expertise both within the team and the partnership as far as possible, inviting external speakers for additional areas of expertise. This is to ensure long-term sustainability of the various programmes.

All events are evaluated either at the end of the session or via a survey sent out to delegates following the course. Colleagues are also emailed certificates with course hours and reflection questions for them to upload to their Social Work England (SWE) portfolios.

## Attendance

**Table 1** below is an overview of bookings and attendance both overall and by partner, where this data was available. Where data by partner was not available, this has been included as Local Authority instead - e.g. data was not available to separate bookings from Sutton Adults' and Sutton Children's colleagues, so they were all combined under Sutton. The TP team plans to capture bookings by partner organisations going forward so that a more detailed and accurate breakdown of attendance can be conducted going forward. Please note that this table covers sessions that took bookings via Eventbrite, and not those that were by invitation only.

The data shows that the highest number of bookings and attendance comes from colleagues in Croydon, followed by Sutton, and then Merton. However it is important to note that this does not account for the size of each authority's workforce, and some are considerably smaller than others. The table also highlights that the level of non-attendance is relatively high for most partners, with an average rate of 35.54% non-attendance across bookings from partners, and 40.63% non attendance overall. This may be due to a number of reasons relating to the pandemic, such as increased/different pressures and workloads. The average non-attendance rate for virtual events is around 35% (Markletic, 2021), and up to 50% for free events (UK Recruiter, 2021). Although the non-attendance from practitioners is within this range, it is not a rate that we would consider satisfactory and this is something that requires ongoing monitoring as well as further exploration to understand the factors behind non-attendance. Currently, the non-attendance data includes both cancellations and no-shows, though the TP team plans to distinguish between these going forward. This will allow for a better approach to tackle the high non-attendance rates.

Appendix 2 shows the full breakdown of individual events and attendance between April 2020 and March 2021.

Looking into the data in more detail, a pattern of increased non-attendance emerged from January 2021. The average non-attendance rate between April 2020 and December 2020 was 38.40%. This increased to 50.68% between January 2021 and March 2021. Again, this may have been due to a number of factors relating to the pandemic, including the post-Christmas lockdown and colleagues facing new challenges as a result, and a level of "Zoom fatigue" after having attended so many virtual training sessions. It may also reflect the deadline for submitting evidence of CPD and registering with Social Work England, which was the end of November. As a result, the TP team recently decided to implement a new policy of feeding back to partner agencies about colleagues that are repeated "no shows". This aims to reduce high non-attendance rates going forward.

**Table 2** below shows the most popular courses by number of attendees. The most popular course overall was around Reflective Writing for CPD, which highlights that



this is an area of need for practitioners. Additionally the Child to Parent Violence event was extremely popular in bookings and number of attendees. As a result, both sessions have been included in the L&D offer for the April 2021 - March 2022 period. Encouragingly, a number of the most popular sessions were related to encouraging Anti-Racist practice, as well as engagement in lockdown. Some events were more appropriate for larger audiences, meaning there were more spaces made available for delegates to attend. This should be taken into consideration when interpreting the data.

Sessions that were 'by invitation only' include the Early Career Managers' (ECM) Programme, the HEI's Coaching and Mentoring PQ module and Action Learning Set (ALS) Facilitation training. These have had 54, 17 and 31 colleagues taking part, respectively. The ECM programme was developed and designed to support social workers newly stepping up into management positions. The 9-day programme was run twice between November 2020 and March 2021, and was so well received that an external Teaching Partnership has commissioned the course to be delivered for their managers, which started in March 2021. The Mentoring, Coaching and Advanced Assessment of Professional Practice module was jointly developed by employers and Kingston University in 2018 and has been commissioned by the TP three times over the last three years. It aims to establish a pool of qualified coaches



across the TP that can support employer partners in developing a coaching culture in their organisation. Partners also designed a set of [Coaching & Mentoring Principles](#) in 2019 to complement the module and give them the tools to implement a coaching and mentoring strategy within their organisations. The ALS Facilitation training was commissioned twice in 2020-21 in order to develop a group of skilled ALS Facilitators across the TP, who could support staff in their own organisations through the process of action learning and provide much needed ALS on the ECM Programme. Action learning is also a key element of the TP's new Early Professional Development Framework, where social workers in their 2nd and 3rd years of practice can access a host of support, learning and development opportunities.

The 9th day of the ECM Programme was intended to be for individual employers to deliver a session on local processes in-house, such as safer recruitment, disciplinarys, complaints and finance. An overview of the topics to be covered was shared with employers and the majority were able to make arrangements for this to be delivered to their managers in-house. However, three agencies were not able to do this successfully and on one occasion, where a session had been arranged, there was a last minute cancellation by a member of the shared service HR team, which reflected poorly on the programme. As a result of this, when submitting the documentation for formal accreditation (see below), the decision was made to remove the 9th day from the programme, although individual employers can still choose to run this day.

The ECM programme was submitted and approved for accreditation with The CPD Standards Office (CPDSO) in March 2021. This has been a positive step for the TP to build its reputation and credibility in providing a high standard of training and learning events. Following this success, a second course, Enabling Reflective Practice was submitted for accreditation, and was successfully approved as well. The TP team has identified 3 further courses to be accredited in the coming months, which are a selection of Practice Educator Workshops: PE Supervision Skills, Assessing & Evidencing Values & Ethics, and Promoting Learning using Direct Work Tools.

With regards to the online resources on offer via the TP website, 'attendance' can be tracked through page hit rates on the website, as well as view counts on the TP YouTube Channel, where some of the videos are hosted. The most visited resource from the website over the year was the 'The Professional Capabilities Framework Toolkit', a mixture of worksheets, exercises and discussion tools that PEs can use with their students on placement. The most popular recorded session accessed, by far, is the recording of 'BASW: Anti-Racism in Social Work with Wayne Reid - September 2020', with 552 views. The recordings of some of the PE workshops only have a few views, which may be due to colleagues not being aware that these are available. The TP team plans to continue building the library of online resources.



## Evaluation and Impact

Evaluation forms are shared with participants either on the day or as soon as possible following the event. These have been created on SurveyMonkey and sent out as links. Appendix 3 is a sample evaluation form. The feedback from all evaluations is collated and shared with trainers and facilitators, used to improve future sessions and inform future commissioning.

Overall, evaluations of the events have been very positive, with 100% of respondents rating the facilitators' knowledge as "Good"/"Excellent", 93.82% rating the sessions as "Extremely Helpful"/"Helpful" and 93.39% rating the sessions as having "Fully met"/"Exceeded" their expectations.

Appendix 4 shows a full breakdown of the evaluations from SurveyMonkey by event. Data for some events (e.g. the NSPCC events) have not been included as the survey questions for these were in a different format, and were not able to be 'averaged' or added into the existing data.

Overall, the return rates for evaluations have been variable (28.82% of those who attended, on average), which does not provide an ideal comprehensive overview. Although feedback is also obtained via other formats, such as stakeholder surveys and email correspondence from colleagues across the partnership, having a different system of sending out the evaluations may provide better response rates. This is something that the TP team plans to look into for future events.

Some of the comments from the evaluations are as follows:

Evaluations for the ECM programme have also been very positive. 100% of respondents from both completed cohorts said that they would “recommend this course to an early career manager”. 86% of respondents said they found the programme “Extremely”/“Very” useful with all other respondents saying it was “Somewhat” useful.

The current system of evaluations provides information about the helpfulness of the events, the skills and knowledge of trainers/facilitators, as well as whether the event met expectations. However, there is no system currently in place for evaluating longer term impact of learning. This is something that the TP team aims to implement going forward, with additional surveys sent to attendees 3 or 6 months after the session they attended.





## Conclusions and Recommendations

Overall, 2235 bookings were made for the provision across the year, and the overall attendance rate was 59.37%. Although the non-attendance rate has been relatively high, considerations should be made for the wider circumstances over the year. Despite this, feedback for the events has been positive, and from the attendance and evaluation data, we can conclude that the Teaching Partnership's L&D offer is meeting the needs of colleagues across the partnership.

From the process of evaluating the data, as well as the data itself, there are a number of recommendations that can be drawn. The recommendations for the L&D offer 2021-22 are:

1. To continue working closely with partners to identify learning needs;
2. To identify a system for follow up impact evaluations 3-6 months post event;
3. To amend the current booking system to allow bookings to be distinguished by partner;
4. To research and procure a new system that incorporates registers, certificates and evaluations;
5. To distinguish between cancellations vs no shows for non-attendance, and implement a new policy to tackle high no-show rates.
